1. General Provisions

This order is issued in accordance with valid resolutions of the Government of the Czech Republic related to the spread of the COVID-19 coronavirus infection, especially for students who have not logged out of the TUL dormitory during the Czech Republic's quarantine and the declared state of emergency and continue to use them.

2. Accommodation of Students, Possibility of Termination of the Accommodation Agreement

Accommodation of students continues to be governed by the concluded accommodation agreement and the Halls of Residence Rules.

TUL leadership recommends that all accommodated students from the Czech Republic and neighbouring countries terminate the accommodation contract and leave the dormitory. The accommodation contracts will be renewed after the start of direct teaching.

TUL leadership alerts the accommodated that the accommodation provider has the right to withdraw from the accommodation agreement pursuant to Article VIII of the agreement if the accommodated violates generally binding legal regulations in the TUL premises and land. This withdrawal clause also applies to violations of this order and valid resolutions of the Government of the Czech Republic relating to the spread of the coronavirus COVID-19 disease, an overview of all resolutions can be found here: <https://koronavirus.mzcr.cz/en/category/press-releases/>

3. Adjustment of Accommodation Rules and the Rules of Stay at TUL Halls of Residence

With effect from 23 March 2020 until further notice, it holds that:

- Entrance to the halls of residence is only allowed to the accommodated students and only upon presenting the accommodation card to the receptionist,
- Ban on external visitors to the TUL halls of residence as well as mutual visits of the accommodated,





- Obligation to respect and behave in accordance with the principles of quarantine of the Czech Republic and the state of emergency, to remain in one's halls of residence and room, not to gather,
- Obligation to wear a medical veil or other protection of the nose and mouth also in the TUL halls of residence,
- Obligation to comply with any sanitary measures that are or will be introduced at TUL halls of residence,
- if the accommodated has been ordered a quarantine due to the suspicion or directly being ill with coronavirus COVID-19, they are obliged to announce this fact electronically to the Koleje a menzy by e-mail at us.koleje@tul.cz and also to the relevant study department by phone or e-mail, so that necessary measures against the spread of the infection can be taken.

4. Final Provisions

This order becomes valid and effective on March 23, 2020 and remains valid until its revocation.
